Warm up Supervisor: Clarification & Reinforcement.

Must be a warm up monitor. This person must be able to communicate with door person. Show host MUST provide this person, failure to do so will result in the circuit providing a warm up monitor at the cost of \$180 per warm up area charged to the show host.

Equipment Inspection: To protect our show hosts facilities, there will be an allotted equipment/ prop inspection time prior to warm up. This is a TOB/TIA Wide ruling. Show host MUST provide 2 adults (1 male 1 female) for the Equipment inspection area.

Membership requests travel time between warm ups. This will be accommodated.

REMINDER:

Warm Up Courtesy: The board and member ship have agreed that no music can be used in a split gym type setting, If you have a separate body and equipment warm up you can use music.

When turning in your performance CD please be sure that your show music is the only track on the CD. Always have at least 1 back up CD.

If there is a problem with your music during the performance, stand up IMMEDIATELY and stop the performance. DO NOT wait until the end of the performance and expect a redo of the performance.

CODE OF CONDUCT needs to be reviewed with your unit. Unit Director MUST sign stating that they have reviewed this with their participants, parents, etc.
